- **Gamma** Secure Collaborative Platform (SCP):
- ✓ Replaces i-SECOM for Asset Recovery tool;
- Accessed via internet browser & connected devices;

- Knowledge Management (best practices, research publications, theme based discussions etc);

- ✓ All valid INTERPOL notices published for corruption- offences & Judicial information;




SCOPE: Secure Collaborative Platform (SCP)

- Collaboration with NCBs, law enforcement entities and other external entities for sharing non – operational information;
- Planning an event in coordination with other agencies or attendees;
- Distributing training material and presentations ahead of a training;
- Providing a space for subject matter experts to share knowledge and discuss ideas pertinent to a specific crime type;
- ✓ Sharing of industry/field best practices among different stakeholders;
- Creation of network of stakeholders;
- Providing a dynamic platform to view videos, presentations, reports and media;
- ✓ Exchange an experience;
- Cooperating on different fields on the basis on the basis of sighted agreements.
